

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://www.thefamilyholistic.com/>, and THE FAMILY HOLISTIC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to THE FAMILY HOLISTIC include <https://www.thefamilyholistic.com/>. The THE FAMILY HOLISTIC website is a Business site. By using the THE FAMILY HOLISTIC website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, THE FAMILY HOLISTIC may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

THE FAMILY HOLISTIC may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. Use of your Personal Information

THE FAMILY HOLISTIC may also use your personally identifiable information to inform you of other products or services available from THE FAMILY HOLISTIC and its affiliates.

Sharing Information with Third Parties

THE FAMILY HOLISTIC does not sell, rent or lease its customer lists to third parties.

THE FAMILY HOLISTIC may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to THE FAMILY HOLISTIC, and they are required to maintain the confidentiality of your information.

Tracking User Behavior

Use of Cookies

- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

Children Under Thirteen
